There is no doubt that this could also have serious consequences at Centre levels (Club & League) through the knock on effect at Junior, YAC and Adult (Team Ireland) levels in particular; for those bowlers and coaches who would no longer be able to aspire to represent their country, now choosing to concentrate on other activities.
